

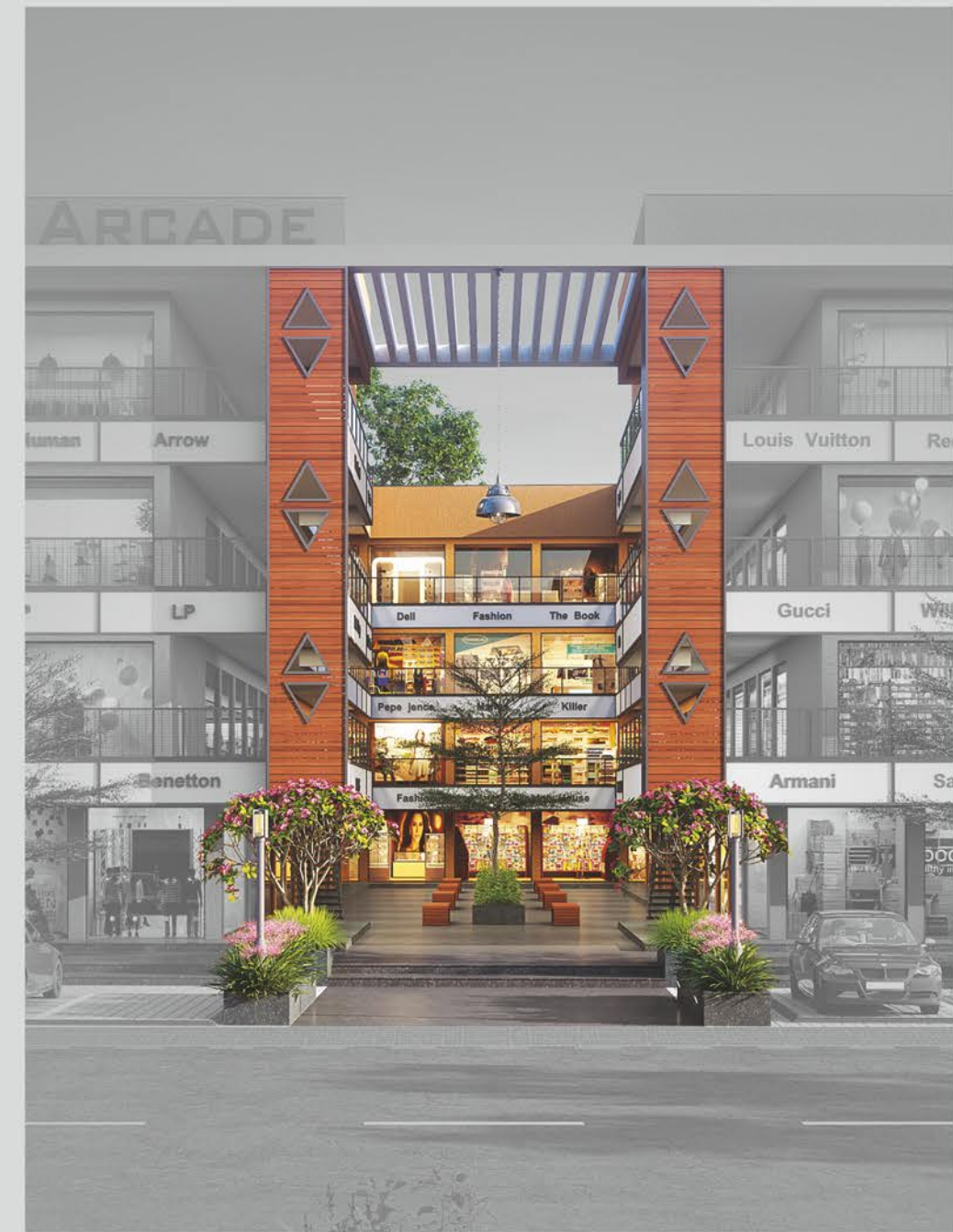

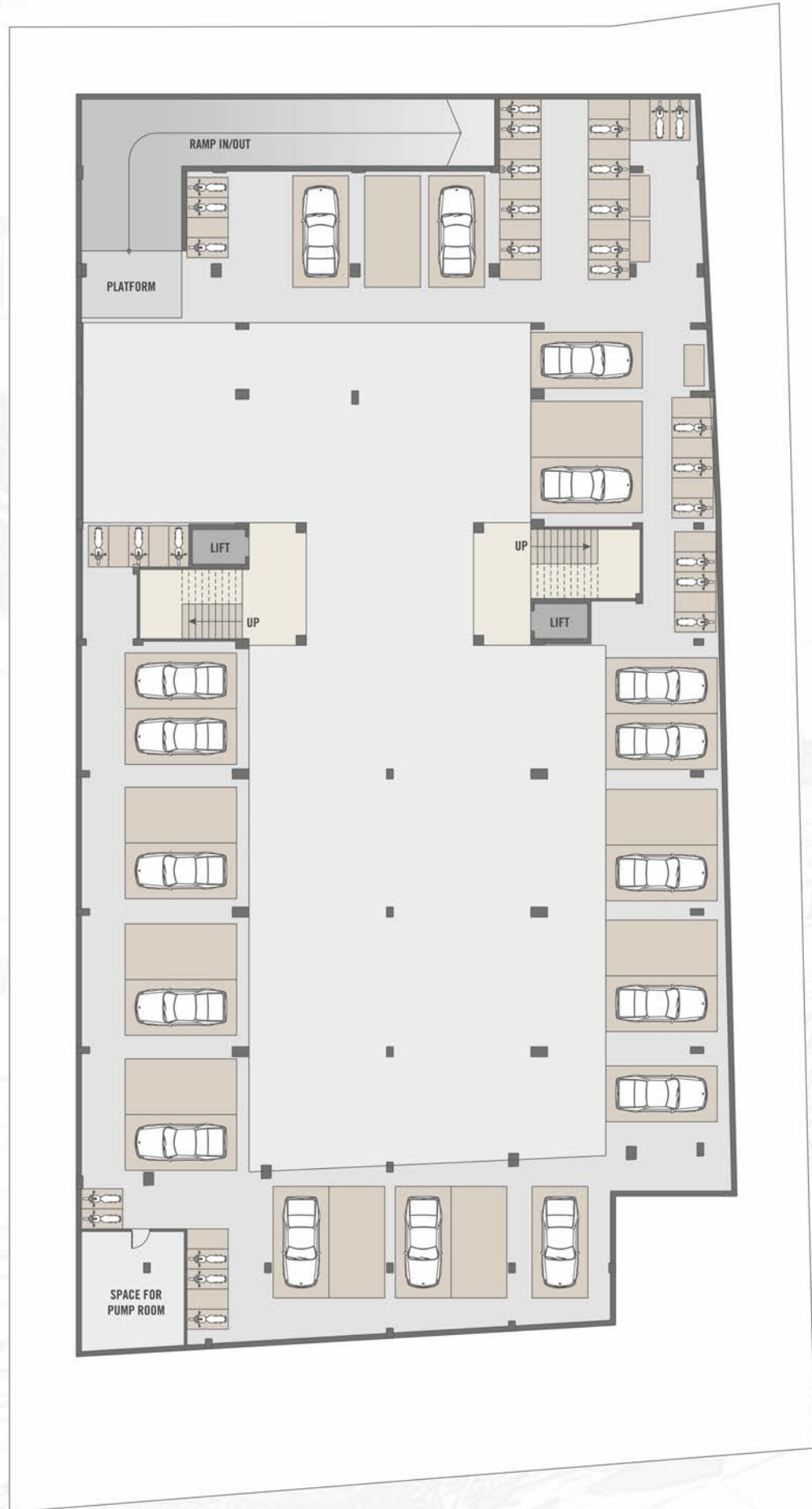


GROUND FLOOR PLAN

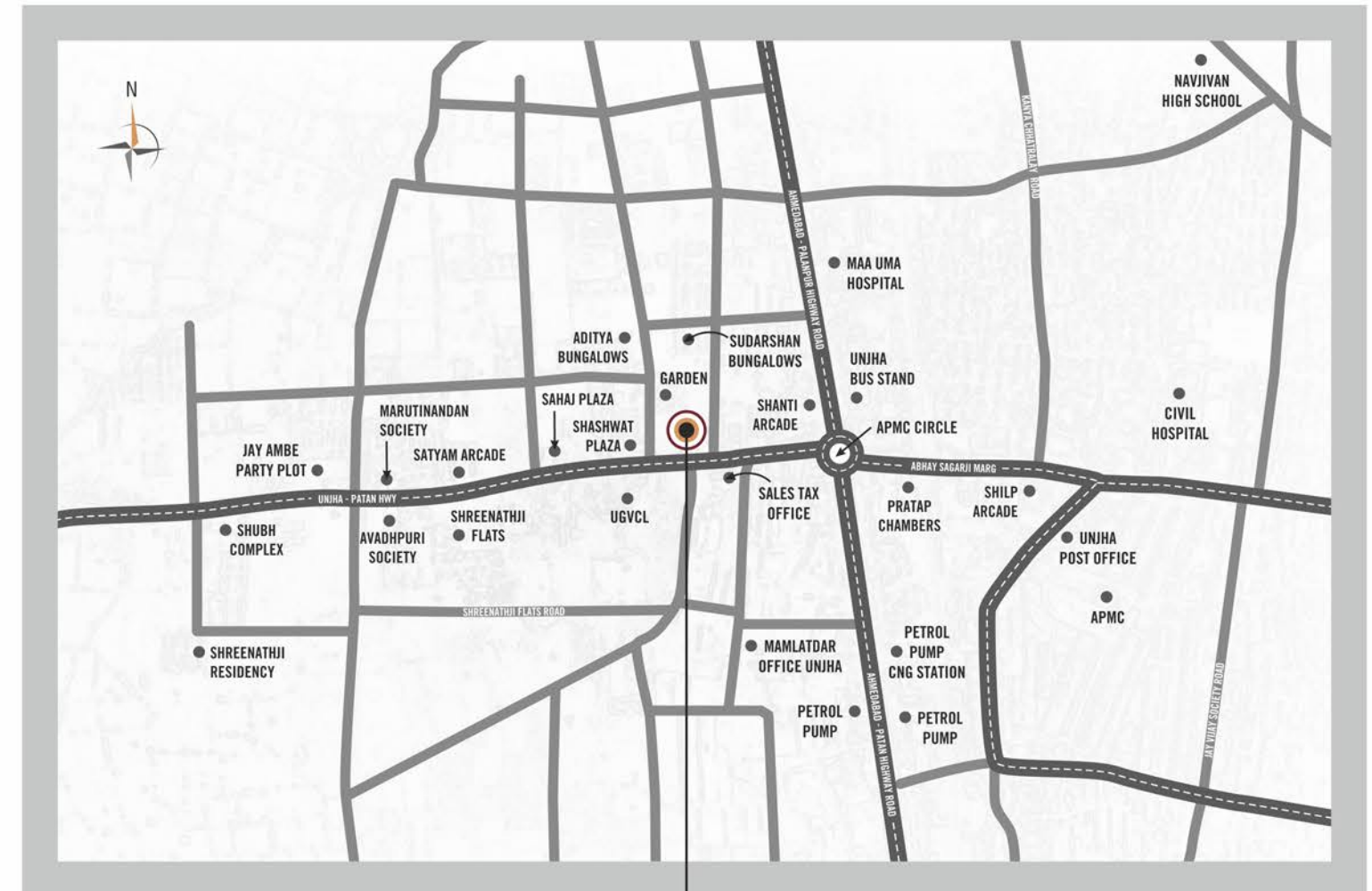


Aluminium Windows as per Elevations
